· Motion for the RAISE Committee to recommend that the Economic Development Authority of the City of Newport News, Virginia (EDA), as fiscal agent for RAISE funds, approve a grant of \$700,650 to the Peninsula Airport Commission (PAC) to serve as required matching funds for a \$950,000 grant from the Federal Department of Transportation (DOT) Small Community Air Service Development Fund, relative to a Transportation Services Agreement (TSA) between PAC and Vision Airlines for service to Newark and Boston with terms as specified in the TSA and in accordance with all DOT grant terms and conditions. The RAISE funds will first be deposited into an escrow account as collateral security for a Towne Bank loan to PeoplExpress until disbursed as a grant in accordance with the TSA..

· Motion for the RAISE Committee to recommend that the Economic Development Authority of the City of Newport News, Virginia (EDA), as fiscal agent for RAISE funds, appropriate \$\_\_\_\_\_ for extension by Addendum of an existing Transportation Services Agreement (TSA) dated July 31, 2013 between the Economic Development Authority of the City of Newport News (EDA) and Frontier Airlines for a continuation of Denver service as specified in the TSA.
